



### Limited Lifetime Warranty

TRUSTAINLESS's Faucet warranty is only applicable to the original purchaser/owner of the faucet for as long as the original consumer purchaser owns the home in which the faucet was first installed. All TRUSTAINLESS Faucets must be installed by a certified plumber to qualify. Warranty excludes all commercial, business, and industrial use. (Proof of purchase may be requested in the event of a warranty claim). This warranty is only applicable for faucets installed in the U.S.

TRUSTAINLESS warrants the steel faucet body, flexible hoses, cartridge, and spray head to be free from defects in material and workmanship under normal residential use and service period of one (1) year from the date of original purchase.

In the event of a TRUSTAINLESS Faucet failure, TRUSTAINLESS will replace, free of charge, during the applicable warranty period, any part or faucet that proves defective in material and/or workmanship under normal installation, use and service. TRUSTAINLESS reserves the right to inspect any faucet reported to be defective prior to replacement of the faucet. All decisions are final. Replacement cost excludes transportation and any labor costs for the removal or reinstallation of the faucet. This warranty does not cover any events of product surface damage caused by abuse, misuse, accidental damage and/or scuffs, poor installation, improper care and maintenance, failure of or dissatisfaction with joints, seams or any adhesive or caulk used in connection with installation, damage caused by harsh or abrasive cleaners and/or materials or failure caused by any act of nature. Any part or product repaired or altered in any manner without written authorization from TRUSTAINLESS will void the warranty.
